Ms. Bennett is founder of Mediation Law Group, Inc.™ As an active litigation attorney, she successfully represented both plaintiffs and defendants in business, corporate and real estate matters in State and Federal courts for more than 13 years. Ms. Bennett received her certification in alternative dispute resolution from the Institute for Dispute Resolution at Pepperdine University School of Law in 1990 (member of the first graduating class) and has mediated and arbitrated over 600 cases. She is a frequent public speaker, instructor and consultant in resolution skills. Ms. Bennett is known for her tenacity in mediation and skill in moving parties to creative and practical solutions to their controversies.



**EXPERIENCE**

Before shifting the majority of her practice to mediation and arbitration, Ms. Bennett practiced law in Southern California from 1991 through 2002, with an emphasis on corporate and business start-ups, real estate, landslide/soil subsidence, construction defect and business litigation. Currently, she maintains a very limited law practice handling a select number of complex family issues, in addition to her full-time resolution practice. Ms. Bennett regularly mediates and arbitrates a wide range of disputes, including wrongful termination and employment-related, personal injury, business transactions, partnerships, contracts, real estate, homeowner associations, construction, landlord-tenant, physician-patient, church, technology, recording and licensing agreements, attorney-client disputes, and family law issues.

In addition to her dispute resolution activities, Ms. Bennett was elected as the first woman to serve on the Murrieta City Council, taking office in November, 2006. As an elected official, Ms. Bennett was instrumental in the establishment of the City of Murrieta's first Youth Court Program, an alternate diversion program for first-time, low-level juvenile offenders. She also serves on the Executive Committee for the Western Riverside Council of Governments (WRCOG), a coalition of 14 local jurisdictions and County Districts. Ms. Bennett is a certified court mediator for the Los Angeles County Courts, Judge Pro Tem/Settlement Officer for the Orange and Riverside County and Superior Courts, Judge Pro Tem (Small Claims Panel) for Riverside County Superior Court, Attorney Settlement Officer for the U.S. District (Federal) Court, Central District, and is an arbitrator for the National Association of Securities Dealers (NASD) and the Better Business Bureau (BBB). In addition to her Certificate in Dispute Resolution from Pepperdine School of Law, Ms. Bennett has over 22 hours of family law mediation training. From 1995 through 1998, Ms. Bennett served three years on the Board of Directors of a community based mediation and arbitration service in Orange County, and a fourth year as Board Chair, where she mediated disputes on a regular basis.
